## LETTER FROM THE DIRECTORS

Since its launch in April of 2023, the University of Michigan Opioid Research Institute has made great strides in centralizing the efforts of faculty, students and staff to reduce the harm of the ongoing opioid epidemic. This transdisciplinary institute works with teams across all three U-M campuses to bolster collaborations and strengthen community engagement, expanding the work of the Opioid Solutions network that was created in 2018.

In an effort to engage with researchers across multiple disciplines, the institute launched both its Visiting Faculty Lecture Series and its Coffee Connections Series in summer 2023. Both of these series of events encourage those conducting opioid-related research to step outside of their traditional areas of work and learn about other work happening in this critical field.

Serving as this central hub for opioid-related research being conducted at the university, the institute has also brought together internal and external partners to catalyze and expand high-impact research. Following the launch of the institute, the Technical Assistance Collaborative was announced - a joint venture between the Michigan Department of Health and Human Services (who also funded the project), the University of Michigan, Michigan State University and Wayne State University to offer local governments assistance in developing abatement strategies to address the ongoing opioid epidemic.

Together, teams across the three universities are working to provide resources such as community needs assessments, analysis with evidence-based recommendations, program implementation support, and evaluation strategies. The TAC is also actively identifying priority communities to immediately address the most critical populations across Michigan. The TAC released its 6-month report in October of 2023.

Being able to share the efforts of the institute has also been a key goal over the past year, with the team working to develop a strategic communications plan. This has so far included launching a quarterly newsletter, producing press releases on faculty publications and announcements, collaborating with other U-M programs and departments on events and revamping the Opioid Solutions website to reflect the branding and priorities of the institute. As we continue to develop our infrastructure, these plans will continue to evolve as well, with the priority being to increase both internal and external awareness and engagement.

At the end of 2023, four faculty members were added to the institute team to lead two domains: Research and Data and Community Engagement. Both domains are crucial to the success of the institute, as they each are charged with furthering the progress not only of the Institute but of the state of science in the field of opioid-related research.

As we enter into our second year, we are inspired not only by the communities we serve and engage with, but also by the students and faculty with whom we work. There is a critical need for opioid-related research in determining best practices and effective solutions to the ongoing opioid crisis. We look forward to continuing these efforts by bringing together the brightest minds and dedicated public and private partners.

### **ABOUT THE INSTITUTE**

The <u>Office of the Vice President for Research</u> and the <u>Medical School Office of Research</u> launched the Opioid Research Institute in 2023 through a \$3 million commitment. The Institute serves as an expansion of the Opioid Solutions network that was created in 2018 to build partnerships among U-M researchers in this space.

The institute serves as a central hub for opioid-related research, bringing together U-M experts and external partners to catalyze and expand high-impact research, programs and collaborations that revolve around opioid misuse treatment and prevention research, community engagement, education and clinical innovation.

The mission of the Opioid Research Institute is to reduce overdose deaths and other morbidities through collaborative, innovative and interdisciplinary research that spans the translational spectrum. ### **COFFEE CONNECTIONS**

In 2023, ORI launched its Coffee Connections event series. These events serve as an opportunity to bring trainees, basic scientists and clinical researchers together to learn from U-M experts on topics related to opioid research. ### **COMMUNITY ENGAGEMENT**

Zingerman's Community of Businesses launched a train-the-trainer model at its Ann Arbor locations in early August 2023. The model allows certified naloxone administrators to train community-based organizations on best practices for providing the lifesaving drug to those experiencing an opioid overdose. This partnership is the first time OPEN has provided the training to a restaurant with the support of ORI, and is led by Dr. Gina Dahlem, Community Engagement Domain Co-Director.

# **TECHNICAL ASSISTANCE COLLABORATIVE**









#### About the Technical Assistance Collaborative (TAC)

States joining the national opioid lawsuits against manufacturers and distributors contributing to the opioid epidemic have secured billions of dollars in settlement funding. Based on the first round of settlements for Michigan, the state is expected to receive around \$776 million over the next 18 years. Of the initial round of settlements reached, around 50% will go directly to county, municipal, and local governments that sign the subdivision agreements. Of the funds received, 70% must be used for future opioid remediation (reversal or stoppage of opioid-related harms).

In the spring of 2022, in anticipation of this funding going to counties, cities, and townships, the Michigan Department of Health and Human Services (MDHHS), brought together the state's three largest research universities, Michigan State University (MSU), University of Michigan (U-M), and Wayne State University (WSU) to discuss ideas on how to best support and assist local governments.

This collaboration resulted in multiple strategy meetings amongst the three universities and MDHHS. In October of 2022, MSU, U-M, and WSU jointly submitted a proposal to MDHHS for consideration to establish the Technical Assistance Collaborative (TAC). The TAC was launched in April of 2023.

The funding for the TAC allowed the universities to build their capacity to provide technical assistance and expertise at no cost to counties, cities, and townships. This has been a collaborative effort in partnership with MDHHS; MDHHS has also served as a liaison between the TAC and relevant statewide associations and organizations.

#### Community Learning Series

U-M and WSU took the lead in coordinating and establishing 10+ online webinars as part of the TAC Learning Series for county, city and township officials and communities interested in hearing from experts related to core strategies and allowable uses of the Opioid Settlement funds. Each webinar included time for a question-and-answer session. Attendance ranged from 17 to over 70 participants, and each webinar was scheduled for an hour to 1.5 hours. These webinars and presentations are recorded, shared with registered attendees, and available to the public upon request.
